Guidelines for NBU 7 Day  
Programmable Thermostat Rebate  
Program

- I. Rebates are applied on any qualified 7 day programmable thermostat. Only NBU approved programmable thermostats are applicable.
- II. This program is available to NBU residential electric customers only.
- III. The program offers one (1) \$25 or 50% of the cost of the thermostat rebate (whichever is less) per 7 day programmable thermostat. Limit one rebate per residential dwelling unit.
- IV. Rebates are paid in the form of credit, which will be applied to the customer's electricity bill following verification of installation. A customer's signature on the application implies consent to a post installation inspection at NBU's discretion and certifies that installation has taken place.
- V. To obtain a programmable thermostat rebate, the customer shall present an original unaltered and dated sales receipt for NBU approval as proof-of-purchase along with a completed rebate form. The make and model number of the equipment must be identified on the receipt. The customer shall provide proof that the thermostat purchased is an approved 7 day programmable thermostat. The purchase of the thermostat must have been made on or after August 1, 2019.
- VI. The customer shall complete the NBU rebate application available at the NBU Main Office at 263 E. Main Plaza or at <http://www.nbutexas.com/Conservation/Rebates>.
- VII. **NBU reserves the right to terminate this program at any time and only NBU approved applications are eligible for payment under this rebate program.**
