## Program Requirements (All requirements must be met)

- Rebates are applied on any qualified single-loaded, new, high efficiency washing machine. Only CEE rated tier 1, 2, or higher, and Energy Star rated washing machines are applicable.

- Visit the Energy Star website at <https://www.energystar.gov/productfinder/product/certified-clothes-washers> for an up-to-date list of qualifying washing machines.
- This program is available to NBU residential water customers only.

- Residential Customers who live in apartment complexes/condos/townhomes that receive NBU water, may qualify for this rebate program even if the customer does not receive an NBU water bill.
- The program offers a maximum \$200 rebate per qualified high efficiency washing machine. Limit one rebate per residential dwelling unit within a 12-month period.
- Rebates are paid in the form of credit, which will be applied to the customer's water bill following verification of installation. A customer's signature on the application implies consent to a post installation inspection at NBU's discretion and certifies that installation has taken place.
- To obtain a washing machine rebate, the customer shall present a dated sales receipt for NBU approval as proof-of-purchase along with a completed rebate form. The make and model number of the equipment must be identified on the receipt. The customer shall provide proof that the washer purchased meets the criteria for High Efficiency specifications for resource efficiency. All rebates and supporting documents must be submitted within one year of purchase.
- New Braunfels Utilities reserves the right to terminate this program at any time and only NBU approved applications are eligible for payment under this rebate program.
