- \_\_\_\_\_ I understand mulch or compost must be installed at least two inches deep to cover 160 square feet or one cubic yard.
- \_\_\_\_\_ I understand that if plants are present in the mulched bed, they are drought tolerant and from the "Comal County List of Approved Plants."
- \_\_\_\_\_ I understand if irrigation is present, spray heads are not used. Drip irrigation is permitted.

- \_\_\_\_\_ I understand the rebate will be paid in the form of a credit on my NBU water bill.
- \_\_\_\_\_ I understand this rebate allows for a maximum of \$100 for mulch or compost only and \$130 for mulch and/or compost plus core aeration per account per 12 months.
- \_\_\_\_\_ Receipts of purchase, and all warranty information must be included upon submission of this application in order for the rebate to be considered.
- \_\_\_\_\_ I understand all rebates and supporting documents must be submitted within one year of the work being performed.
- \_\_\_\_\_ I agree to allow NBU to perform any necessary inspections, both during initial installation and in the future.
- \_\_\_\_\_ Acceptance of this incentive will not exceed NBU's annual program customer limits and may be terminated at any time.
- \_\_\_\_\_ I understand that NBU reserves the right to terminate this program at any time and only NBU approved applications are eligible for payment under this rebate program.
