\_\_\_\_\_ I understand the application, original sales receipt, or paid invoice indicating the date of purchase, dealer name, and dealer address, must be submitted within 1 year of purchase date. All qualifying trees must be planted within 15 days of purchase.

\_\_\_\_\_ I understand this program provides up to a max of 5 trees or \$500 per account per 12 months, which will be applied as a credit on my NBU electric bill.

\_\_\_\_\_ I agree to allow NBU to perform any necessary inspections, both during initial installation and in the future.

\_\_\_\_\_ I understand that trees cannot be planted within utility easements and agree to follow all prescribed placement, planting, and maintenance procedures. If the tree is expected to exceed a maximum height of 25 feet when fully grown, then the tree must be planted more than 20 feet away from overhead utility lines.

\_\_\_\_\_ I understand that to qualify for the rebate, the purchased tree must be planted within 10 to 35 feet from the building's foundation and only in the eastern, southern, and western directions from the home.

\_\_\_\_\_ I understand that NBU is not responsible for any personal or property damage incurred by participation in this program and that NBU does not guarantee the survival of the tree.

\_\_\_\_\_ I understand NBU reserves the right to deny any rebate request if the applicant does not conform to the program qualifications, procedures, and specifications; no exceptions.

\_\_\_\_\_ I understand NBU reserves the right to terminate this program at any time and only NBU approved applications are eligible for payment under this rebate program.
