_____ I agree to allow NBU to perform any necessary inspections, both during initial installation and in the future.

Program Requirements (All requirements must be met)

Rebates are applied on any WaterSense-labeled, Ultra-High-Efficiency Toilet (1.1 gallons/flush or less) that are purchased and replaces a toilet with a flush volume of 1.28 gallons or greater.

- This program is available to NBU residential water customers only.
- A maximum of two toilets may be rebated within a 12 month period.
- Tiered payouts will be based on flush volume.
 - a. Standard - **\$50** per toilet for 0.9GPF to 1.1GPF
 - b. Preferred - **\$100** per toilet for 0.8GPF or less
- Applicant is subject to a post-installation inspection.

- The customer can receive the NBU rebate application available online and submit it with a copy of the sales receipt or invoice that indicates the make and model of the toilet and the date purchased for NBU approval as proof of purchase. - Rebates are paid in the form of a credit, which will be applied to the customer's NBU water bill following approval of application.
