

## Guidelines for NBU Smart Thermostat Rebate Program

- I. Rebates are applied on Ecobee and Nest programmable Wi-Fi enabled smart thermostats. Only NBU approved smart thermostats are applicable.
- II. This program is available to NBU residential electric customers only.
- III. The program offers one (1) \$85 rebate per Ecobee or Nest programmable Wi-Fi smart thermostat. Limit one rebate per residential dwelling unit.
- IV. Rebates are paid in the form of credit, which will be applied to the customer's electricity bill following verification of installation. A customer's signature on the application implies consent to a post installation inspection at NBU's discretion and certifies that installation has taken place.
- V. To obtain a smart thermostat rebate, the customer shall present an original unaltered and dated sales receipt for NBU approval as proof-of-purchase along with a completed rebate form. The make and model number of the equipment must be identified on the receipt. The customer shall provide proof that the thermostat purchased is an Ecobee or Nest programmable, Wi-Fi enabled smart thermostat. I understand all rebates and supporting documents must be submitted within 12 months of the thermostat being purchased.
- VI. Customer agrees by completing the rebate application to participate in any future NBU energy incentive programs.
- VII. The customer shall complete the NBU rebate application available at the NBU Main Office at 263 E. Main Plaza or at http://www.nbutexas.com/Conservation/Rebates.
- VIII. NBU reserves the right to terminate this program at any time and only NBU approved applications are eligible for payment under this rebate program.
